(U) I, WENDY M. HILTON, hereby declare and state:

1. (U) I am an Associate Information Review Officer (AIRO) for the National Clandestine Service (NCS) of the Central Intelligence Agency (CIA). I was appointed to this position in March 2007. I have served in a number of positions since I became a staff employee of the CIA in 1983. I make the following statements based on personal knowledge and information made available to me in my official capacity through the review

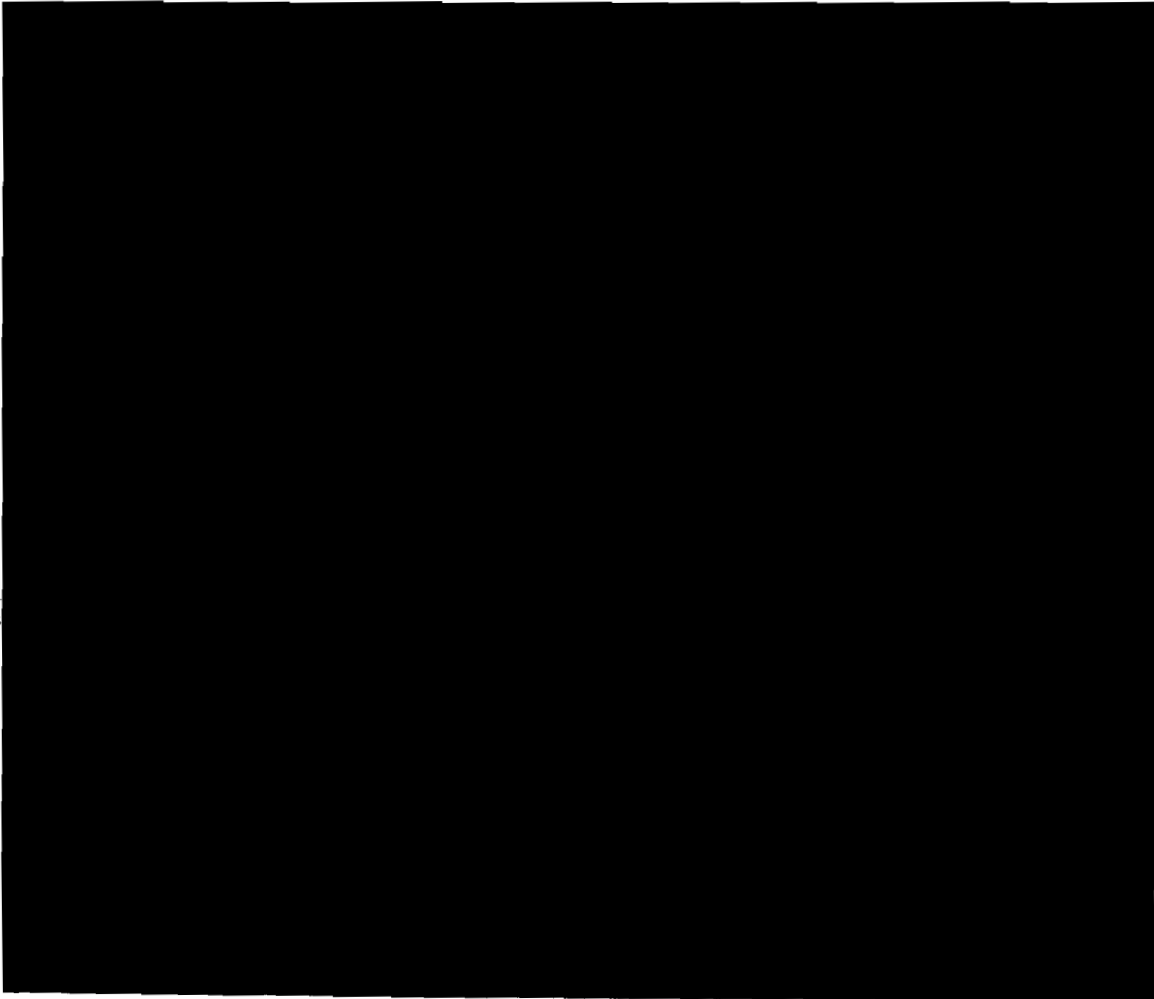

of documents to which I have access, without conducting interviews.

2. (U) With regard to the specific known instance when the CIA destroyed videotapes in 2005 of certain interrogation sessions with terrorist suspect Abu Zubaydah, intelligence reported in official cable traffic from interrogations, debriefings, and interviews with Abu Zubaydah was electronically transmitted to CIA Headquarters and has been preserved.
