DECLARATION OF TERRY M. HENRY


Pursuant to 28 U.S.C. § 1746, I, Terry M. Henry, hereby declare:

Dear Julia and Marty:

As I discussed with Marty on Friday, please find enclosed bates-stamped medical records that have not previously been produced to you from the period of November 30, 2005, through January 4, 2005, during which Mr. Al Joudi (ISN 025) was being involuntarily fed. We are still investigating how these records were omitted from the prior production of records under Judge Kessler's October 26, 2005 Order. A few of the pages, however, reflect the addition of notes made by medical personnel after the record was copied for production, and the record apparently was not re-copied for the next subsequent production at the time.

As with prior productions, these records contain the redactions of identifying information, including names, signatures, and initials, pertaining to medical providers.

I note that in your recent filing in this case, you have characterized these documents as part of the 136 pages of medical records covering the period January 6 through August 11, 2006 (the time period during which Mr. Al Joudi alleges he was involuntarily fed but was not), discussed in respondents' response to the Court's October 16, 2006 Order. This is not correct; as stated above, the attached documents pertain to an earlier timeframe.
