**Declaration of Abdullah Al Kandari**

**(Typed Version)**

I hereby declare under penalty of perjury of the laws of the United States of America that the following is true and correct:

1. I am over eighteen years of age; I am a citizen of the State of Kuwait; and I have never been charged with or convicted of any crime.
2. I have been imprisoned at Guantanamo since the beginning of 2002. We are treated here worse than animals, without any dignity or respect. I have never supported terrorism; I totally oppose it. I have never fought against the United States or done anything against it.
3. During the last visit by my lawyer, Mr. Wilner, a few weeks ago, I was on hunger strike. At that time, I had not eaten for 15 days. I began eating again after Mr. Wilner visited me.
4. As I told Mr. Wilner during that visit, the guards had several times taken and searched my legal file and read the documents and taken documents from the file. They have done this again immediately after Mr. Wilner left and I returned to my cell, even though Mr. Wilner had clearly written on the file that it is confidential.
5. After Ramadan, if I am not released, or charged and given a chance to defend myself in a fair proceeding, where I can know and defend myself from any charges against me, I will again go on hunger strike or otherwise end myself. It is better for me to be dead than to stay in such a place where I am treated worse than an animal and have no

chance to show my innocence. I am giving Mr. Wilner and Ms. Huskey my will to say what should be done on my death.


