I do not permit SMITH, the lawyer or any other one to speak on my behalf from this date 28th February, 2006, corresponding to 28 Muharam, 1427H. I've sent him a letter in this regard.

My dropping-off the case against America is not because I have no complaints, nevertheless it is because of having assurance and more certainty during this lengthy period, that there will be no outcome -ever- from all these American Dramas that are so called, Courts and that even the Lawyers are an important part of this silly Drama that is so called American Democracy.

We came to know it and be aware of it. The Lawyers had announced talk and referred to writings that we had never said or wrote. This is why I am sending this notice to your stinky court. I am forbidding those lawyers who are mentioned above to speak in my name and on my behalf. If the Lawyer disobeys this order, I will take all necessary steps from whatever is facilitated for me now in the prison or when I leave the prison.

The Almighty says "We have rejected you and there has arisen, between us and you, enmity and hatred forever- unless ye believe in Allah and Him alone".
